### MEETING MINUTES

#### 1. INTRODUCTIONS

Introductions were made. A moment of silence was held in honor of the former TAC member John Sabotka.

#### 2. APPROVAL OF APRIL 24TH AGENDA

Motion made by Courcelle to approve the agenda. Second by Potter. **Approved by unanimous voice vote.**

### 3. APPROVAL OF MARCH 27TH MINUTES

Motion by Baccei to approve the March 27<sup>th</sup> minute. Second by Atherton. **Approved by unanimous voice vote.**

### 4. OPEN TO PUBLIC

None present.

### 5. TRANSPORTATION UPDATES

Pepin reminded the TAC that member forms are due back to confirm the appointment of TAC members for this fiscal year. Pepin noted that current TAC members could continue to serve until July 1, at which point they would no longer be a member of the TAC unless they have been reappointed by their town's legislative body. Pepin also noted that the funding for Better Roads category A grants was running out and that any towns who would like to access the funding should submit a LOI. Pepin explained that the State of Vermont was requiring all communities to conduct a Road Erosion Inventory reassessment by the end of September 2027 and that communities who did not receive funding would still have to complete the inventory.

### 6. RUTLAND REGIONAL PLAN: TRANSPORTATION POLICIES – Pepin provided background information on the Rutland Regional Plan and noted that this round the Regional Planning Commission was conducting a full rewrite from the ground up. Pepin then also briefly covered the Future Land Use maps being developed as part of the recent Act 181 changes to Act 250 as well as the 'Complete Streets Implementation Matrix', which aligns the Future Land Use categories with road design that is context sensitive. Pepin then presented the rest of the draft policies for the Transportation Chapter, as well as the major Regional transportation improvements identified as part of the process.

Motion by Potter to recommend that the RRPC Board adopt the draft policies and prospective transportation projects outlined Regional Plan Transportation Chapter. Second by Atherton. **Approved by unanimous voice vote.**
