# **Rutland Southern Vermont Regional Airport Committee**

Meeting Minutes (Reconstructed)

Date: October 28, 2025

# **Opening Discussion**

- Jim Marsh opened the meeting with a discussion focused on revitalization and development at Rutland–Southern Vermont Regional Airport.
- Topics included infrastructure upgrades, increased commercial and general aviation activity, and modernization of facilities.
- Bob Knudsen emphasized the need for new hangars, modernization, and sustainability improvements.
- A sign-in sheet was circulated, and members noted the importance of maintaining accurate contact information.
- Bob reported ongoing efforts to identify funding sources, including a proposed bill to exempt aircraft sales from state sales and use tax.
- The committee discussed outreach to business and political stakeholders and collecting data on aviation demand, particularly from the Killington region.

## **Airport Development and Funding Initiatives**

- Feasibility study to evaluate potential terminal expansion and modernization.
- Pursuing grant opportunities such as Northern Borders Regional Commission (NBRC) funding.
- Legislative support for aircraft sales tax exemption as a growth incentive.

#### **Aircraft Sales Tax Discussion**

- Paul Carroccio noted the need to differentiate between general aviation and commercial classifications in tax language.
- He suggested that tax revenue generated at each airport remain earmarked for improvements at that facility.

### **Grant Opportunities**

- Carroccio reviewed potential NBRC and federal programs such as the Innovative Finance and Asset Concessions Grant.
- Projects may include ADA upgrades, terminal utilities, and runway improvements.
- Deadline for NBRC applications: November 3, 2025.

## **Feasibility and EAS Subsidy Concerns**

- Discussion on the feasibility study to guide investment priorities.
- Acknowledged potential impacts of the federal government shutdown on Cape Air's Essential Air Service (EAS) subsidies.

## **Hangar Development and PFAS Update**

- Four new hangars are in development; PFAS liability will not transfer to tenants.
- Act 250 permitting expected to take 3–6 months, with submissions planned by March 1, 2026.
- Estimated construction cost: \$200 per square foot plus infrastructure.

## **Economic Development and Outreach**

- Engaging contractors and business leaders such as Mike Salamato and Bruce Schmidt.
- Potential support from VEIL could be pivotal for project success.

## **Act 250 Permitting Discussion**

- Concerns over complexity and delays caused by Act 250 requirements.
- Recommendation to reframe around modernization, safety, and sustainability.

## **Demand and Capacity Discussion (Killington Area)**

- Kerah Book noted rising demand from Killington visitors and new residential development.
- Bob recommended gathering quantitative data on private jet activity.

### **Hangar Ownership and Safety**

- Proposal for committee ownership and leasing of hangars as a revenue strategy.
- Safety concerns raised regarding aging hangars; state involvement may be required for condemnation or rehabilitation.

#### **Action Items**

- Brian Collamore: Edit the bill to exempt aircraft sales from Vermont sales and use tax (commercial operations still taxed except flight schools/training).
- Chris Beitzel: Identify and share grant opportunities; coordinate on terminal leasing possibilities.
- Jim Marsh: Oversee initiation of feasibility study and modernization plan.

### **Approval of Previous Minutes**

Motion by Brian Collamore to approve previous minutes. Motion passed unanimously.
